Our aim is to provide free access to Live Active Leisure venues to support talented athletes in their personal training so that they can develop to their full potential and achieve world class performance levels

## Criteria

The athlete must either be resident in Perth and Kinross or a member of a Perth and Kinross constituted sports club. The athlete must also represent their sport\* at any of the following standards:

- Scottish Institute of Sport
- Scottish/British/European/World Championship Title Holder
- Scottish or Great Britain Team Squad Member

\*Eligible athletes must participate in a sport that has a governing body recognised by Sportscotland. Evidence of this should be included within the application process through Sportscotland's verification form.

## Process

1. The athlete should complete the application form and get it endorsed by the relevant NGB or Area Institute / Squad Coach.
2. The application should then be submitted to Live Active Leisure, where it will be assessed.
3. The athlete will be sent notification of the outcome of their application, including any particular conditions which may affect their access to our leisure venues.

2. The completed application form should be submitted to Live Active Leisure.

4. The LAL venues available for use by the athlete and the times at which they can be used will be at the discretion of the venue Operations Manager. Bookings can be made up to 7 days in advance, terms and conditions apply.
5. Access is only available to athletes for their individual training requirements and will not apply to squad, club or team training. Tutored class and activity sessions operating in the venues are not included in this Talented Athletes Scheme.
6. Applicants may be required to take part, wherever possible, in appropriate publicity and promotional events on behalf of Live Active Leisure. Under such circumstances your contact details will be shared with the relevant external agency leading on the publicity and promotional events.
